

HKT Care – Voucher for Eligible SME Customers of HKT Promotion

Terms and Conditions

1. The “HKT Care – Voucher for Eligible SME Customers of HKT” promotion (the “**Promotion**”) is arranged and brought to you directly by HKT Care, a service brand operated by HKT Financial Services (IA) Limited (“**HKTIA**”). HKTIA is a wholly owned subsidiary of HKT Limited (HKT Limited is a company incorporated in the Cayman Islands with limited liability). HKTIA, being a registered licensed insurance agency under the Insurance Authority of Hong Kong (“**IA**”) (Licensed Insurance Agency Licence No.: FA2474), acts as an appointed licensed insurance agency for certain insurers to arrange for certain insurance product and provide related services.
2. The Promotion is valid from 10 February 2026 to 31 March 2026, both dates inclusive (“**Promotion Period**”).
3. The Promotion is only applicable to eligible small and medium-sized enterprise (“**SME**”) customers (“**Eligible SME Customer**”) who received the designated promotional email from Hong Kong Telecommunications (HKT) Limited (“**HKT**”). Eligible SME Customer may be entitled to HK\$300 Supermarket voucher (“**Voucher**”) upon the completion of designated HKT Care’s Employee’s Compensation Insurance online quotation form (“**HKT Care e-Form**”) and obtain quotation via HKTIA, by its duly appointed staff member (“**Offer**”).
4. The quota for the Offer is limited to 500 units, available on a first-come, first-served basis while stocks last. Each Eligible SME Customer is entitled to the Offer once only.
5. The use of Voucher is subject to the relevant terms and conditions of Provider, available at the back of the Voucher.

Eligible SME Customer must ensure the contact information provided is valid, correct and up to date. All contact information is subject to the records of HKT Care, which shall be final and binding. Incomplete and/or incorrect contact information will result in HKT Care being unable to contact Eligible SME Customer and may result in the inability and/or failure of the Eligible SME Customer to receive the Voucher.
8. If the Voucher is lost, leaked, inaccurate, unidentifiable or damaged by any reason, HKTIA will not be liable in any way if the Eligible SME Customer shall suffer any loss as result. Vouchers will not be re-issued under any circumstances. None of HKTIA or HKT shall be responsible for any accidental or unauthorised use of the Voucher by any unauthorised person. None of HKTIA or HKT will be liable or responsible for providing any compensation to any person in such circumstances.
